we have to cancel the tournament. We could participate in The Longest Day, a fundraiser for Alzheimer's and make it for a week in lieu of the tournament if we decide the April tournament is not feasible.

- Novice tournament. Julie brought up the idea of having a Novice tournament. There might be many El Paso people who might be interested. No further discussion at this time.
