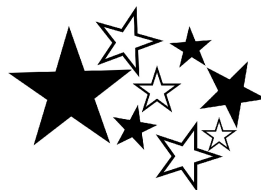

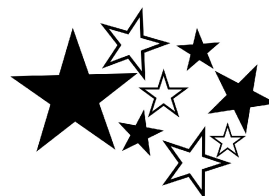

Bridge Logic: Who Has What?



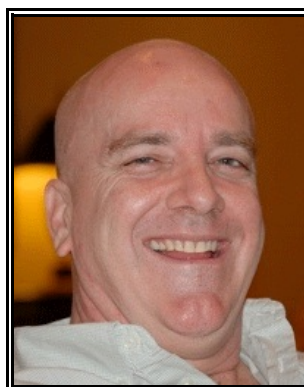
Join 3-time Top 500 Champion Chris Compton for a session of thinking logically on defense. Have you ever had a partner who never gives signals? Chris will walk you

Gold Rush Pairs

Regional schedules in the Western Conference have expanded the popular Gold Rush Pairs, facilitating a need for definition of exactly what the Gold Rush event is, and what it awards. It is really a Strati-Flighted Pairs event with Flight A played separately and open to all players, while simultaneously, the Gold Rush Pairs is limited to players with 750 MPs or less, playing in their own event. The lower Gold Rush flight is normally stratified into 0-100/300/750. Flight A has recently been expanded to three strats: 0-1500/3000/3000+ The Gold Rush draw is the 750 strat winners are awarded gold points for overall placings, and also for section top winners (you must beat *all* players in your section to be awarded gold, not just the 0-300 players). This event allows players to win gold points without ever competing with, or against, anyone with more than 750 masterpoints.
