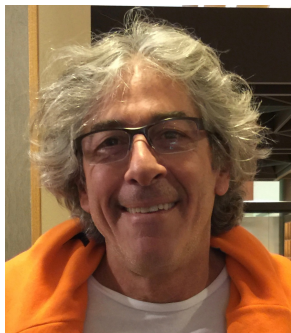

with a great sense of humor. Mike and wife Nancy (also a world champion) live in Dallas.



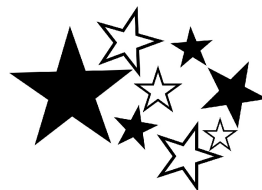

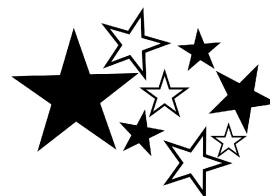

Bridge Logic: Who Has What?



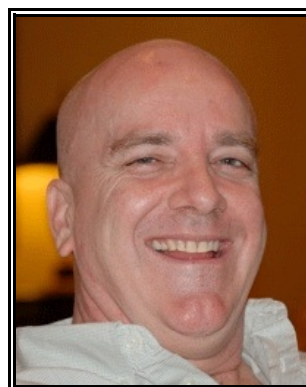
Join 3-time Top 500 Champion Chris Compton for a session of thinking logically on defense. Have you ever had a partner who never gives signals? Chris will walk you

After failing in this slam which was played at the Dyspeptics Club, from which many of these hands are reported, a disgruntled declarer claimed he had given it his best

shot. As usual, his partner disagreed and suggested a better approach.

What's your take?

After *West* had overcalled 1♠ and *South* reached 6♥, declarer captured the ♠K (as ducking it would obviously allow a spade ruff) and went about his business – in vain. *South* should have been able to capitalize on the fact that *West's* overcall found his partner with only one spade – an obvious plus factor for declarer. *South's* goal was to avoid two spade losers but could not conceive of a way to accomplish his purpose. He reeled off his trumps but that accomplished nothing. In the fullness of time, he lost two spades.

However, there was a legitimate way to succeed if he went about stripping the hand. *South* needs a count on the club suit. After winning the opening ♠K and drawing two trumps, he cashes the ♦A and ♦K (discarding a spade in dummy) and plays the ♣A - ♣K and ruffs one. When *West* shows out, declarer can safely get back to dummy's trump, and on his last club he can pitch one of his spades. But ... that is all *East/West* can collect because *East* is forced to give declarer a ruff and sluff as his arsenal now contains only the minor suits.

Result: 6♥ making!
