It is a generally accepted principle to most experts that when both sides are pushing with distributional values, bidding once more beyond your "comfortable" limit is suggested. At rubber bridge the risk is minimal when both contracts fail and the risk can be exceedingly high when both contracts succeed. Let's look at today's deal and how it materialized.

South routinely ruffed West's opening of the ♦K, pulling trump and taking a losing heart finesse to East who returned a club through South's king ... for down one.

Most bridge players are defensive and here was a classic example. South offered: "I made the correct decision although they go down at 5♦ – adding that both the ♥Q and ♣A were badly placed for him (and playing rubber bridge getting credit for 100 honors eased his conscience)."

Playing rubber bridge was of no importance. He was just making lame excuses. What he overlooked was that nothing else should have mattered aside

from keeping East off lead. His partner picked up on it by his cryptic reply ... "Perhaps you should have made 5♠." What did he have in mind?

Had declarer thought ahead, he would have realized that by taking an unnecessary heart finesse, he endangered his ♣K to capture by West's ace (if his heart finesse lost). Surely he was unlucky. However, luck would not have entered the picture had he concentrated more when the ♦K hit the table. How about pitching a heart in preference to ruffing? What could the defender do? Not a thing – other than cash the ♣A! Pitching a heart kept the danger hand off lead. South could now ruff out the ♥Q, gets back to dummy with a trump and pitch his losing clubs.

You can't go down on this hand unless it is by your own carelessness. Don't be blindsided by an instinctive reaction at trick one! Think, think, think!
