Bobby Wolff's Bridge

Here is a routine 3NT contract which begins with the lead of the ♥K, the mandatory overtaking with the ♥A, and a return of the suit ... with the enemy cashing four hearts and leaving the onus of bringing in the entire diamond suit to the declarer.

The normal play is the finesse of the ♦Q by leading toward the jack. When it holds, the location of the queen is obvious and declarer is forced to play for four diamond tricks when the ♦A brings down the ♦10 and a third diamond brings down the queen, and arrives home safely with nine tricks. It appears like a no-brainer.

However, *West* can plant a seed of doubt in declarer's mind. How's that? What if (in normal tempo) with the play of the ♦A, he follows with the ♦Q. Who has the ten? That gives declarer pause for thought. Hoping that the ♦Q is a forced play reflecting the holding of a doubleton, isn't it

astute of a normal declarer to assume *East* began with ♦10543 and confidently finesse the nine, losing to the ♦10 for down one?

How does *South* know if *West* held ♦Qx or ♦Q10x? He doesn't! However, with the drop of the queen, it does present a problem. Otherwise, declarer has no choice but to play for ♦Q10x.

Sometimes *South* will guess right and sometimes he will guess wrong. However, unless the S♦Q becomes an issue by *West* dropping the card he is known to have, declarer will have no choice but to guess right, as he does not have an option.

Great combination! Watch for it.
